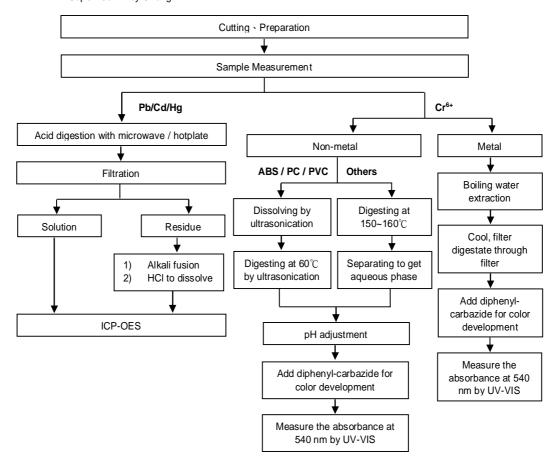

Analytical flow chart - PBB / PBDE

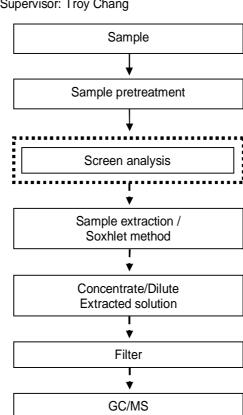

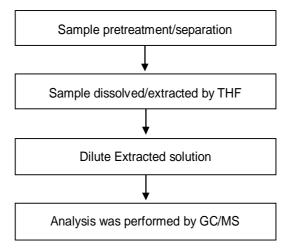

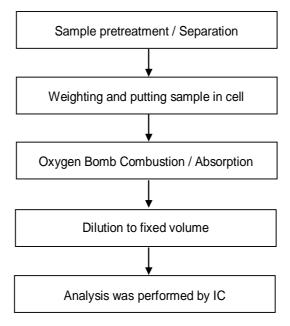

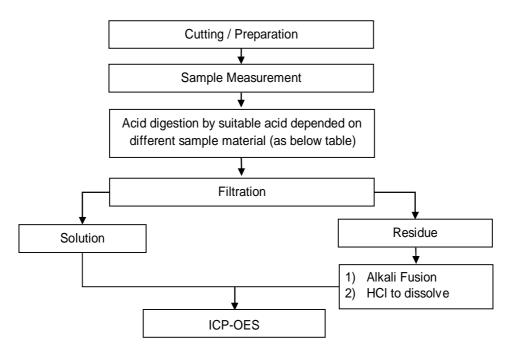
