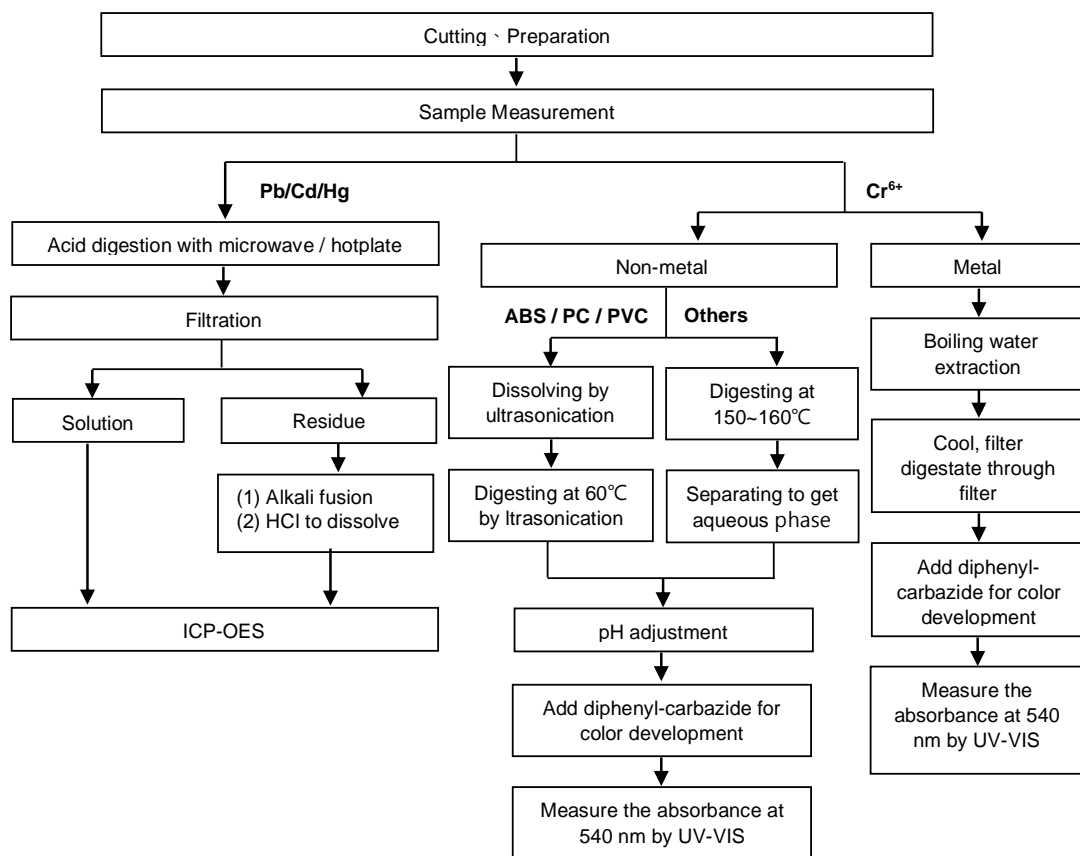

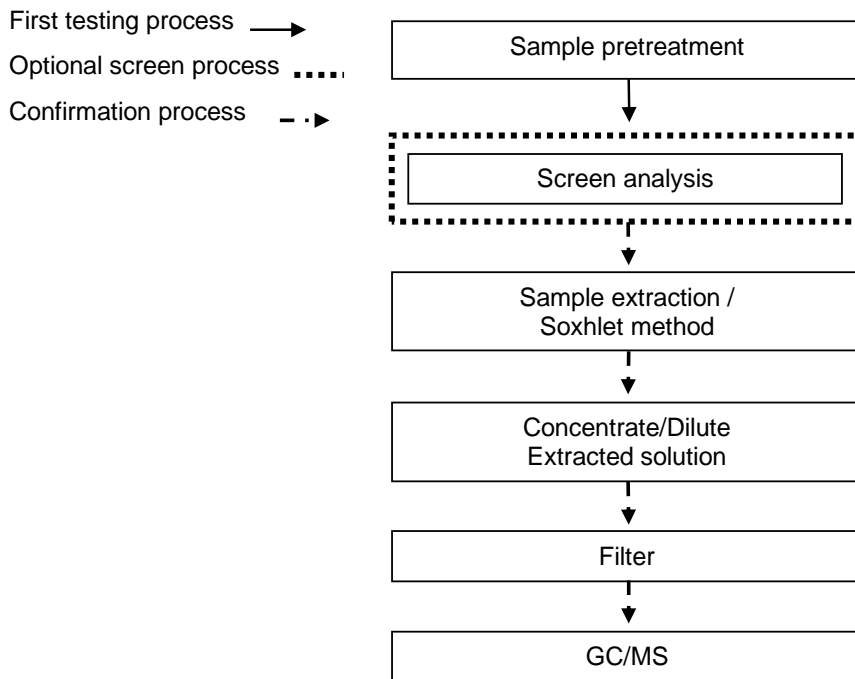

Analytical flow chart – PBBs / PBDEs



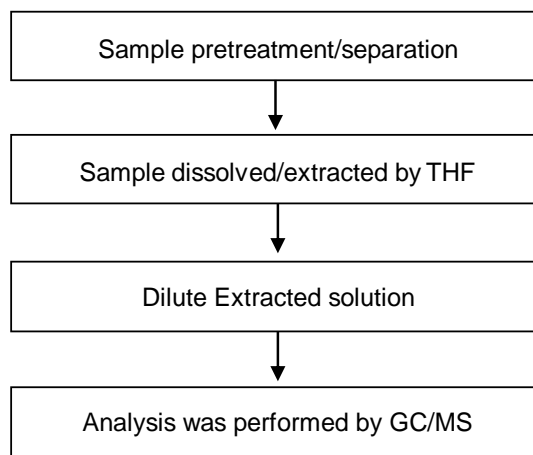

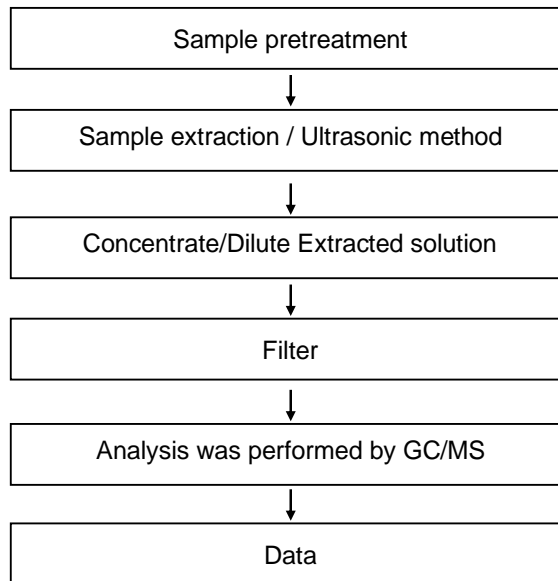

Analytical flow chart - HBCDD

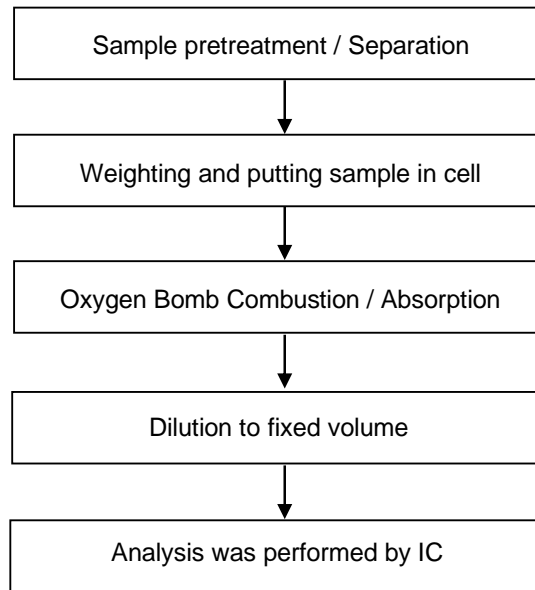

Analytical flow chart - Halogen



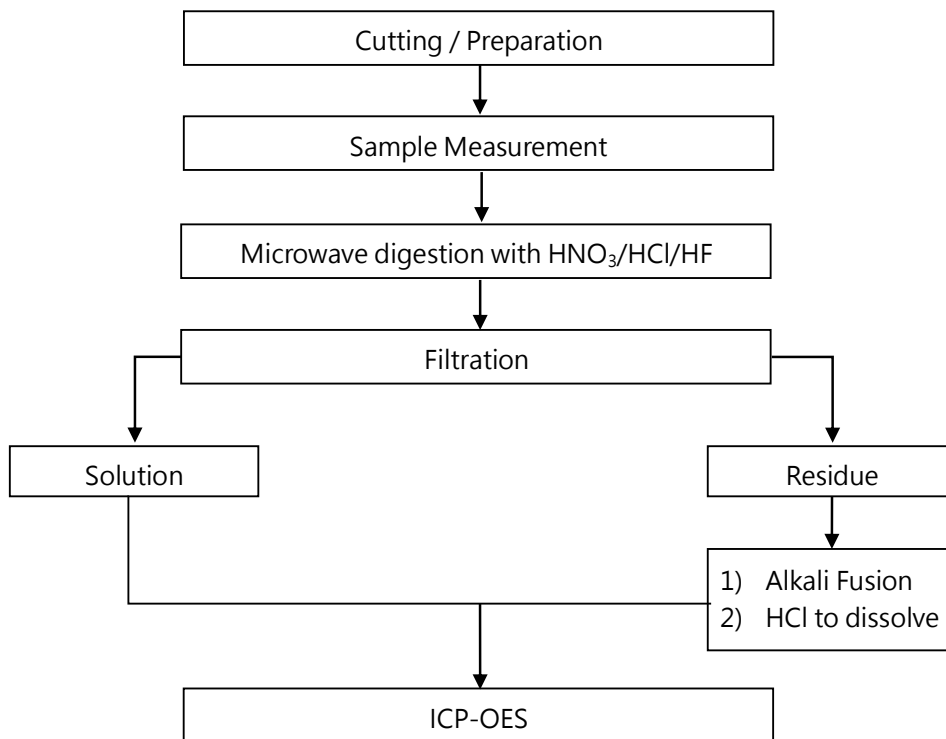

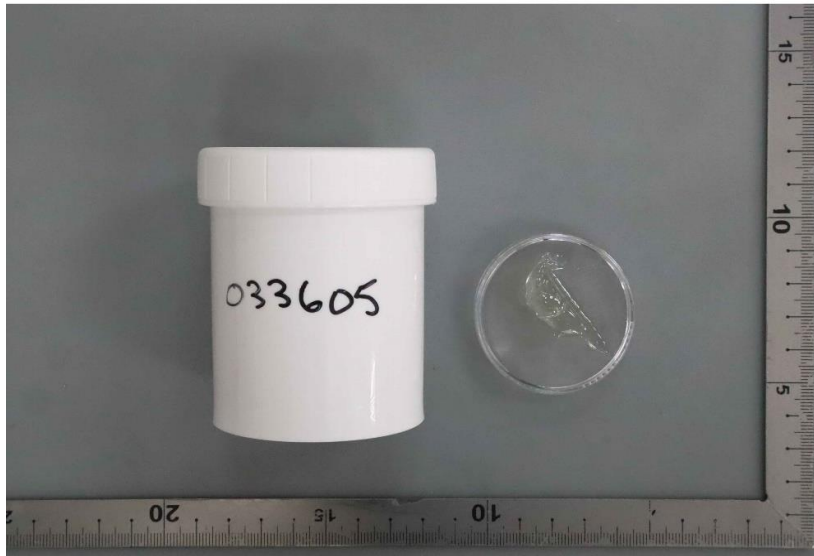
