

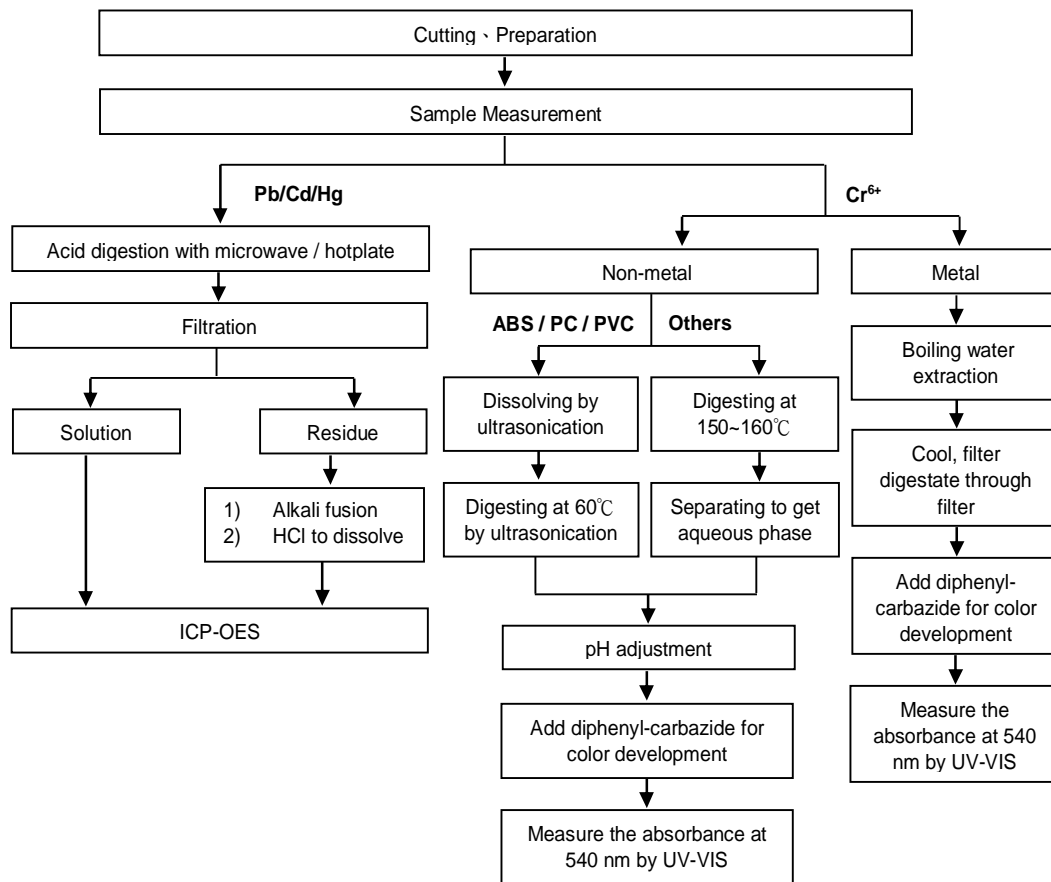

Analytical flow chart of Heavy Metal

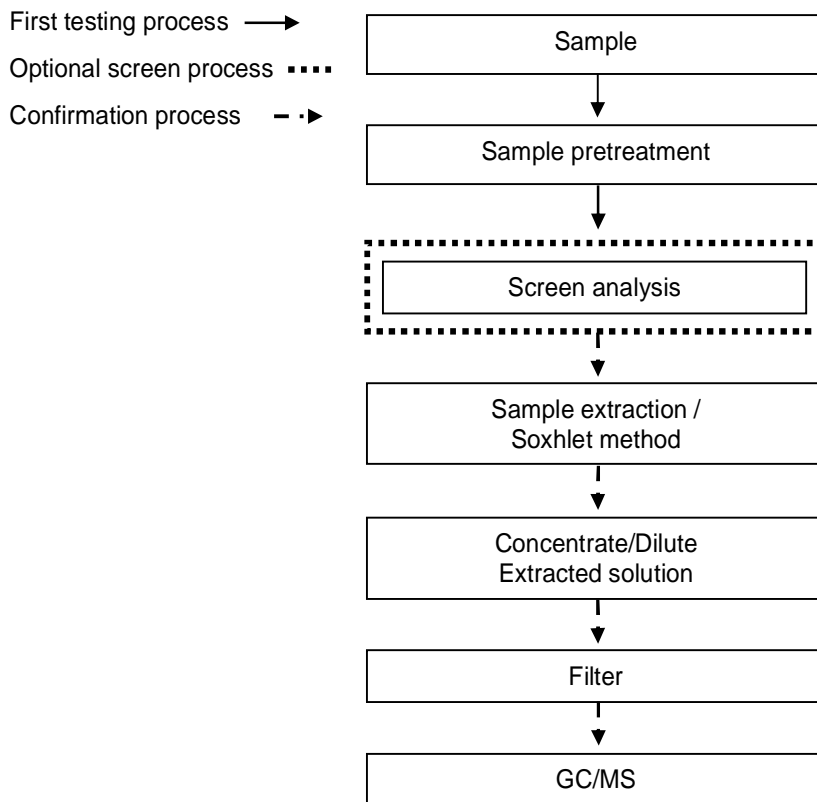

Analytical flow chart – PBB / PBDE

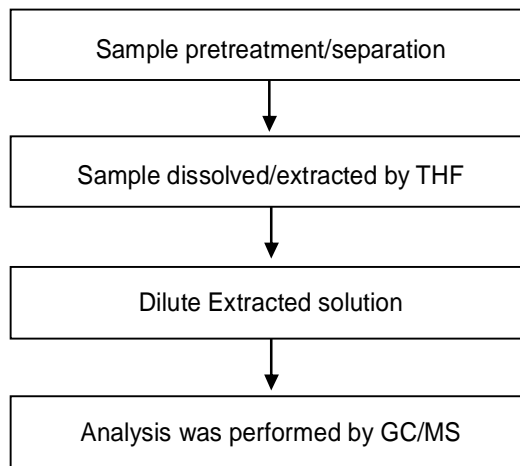

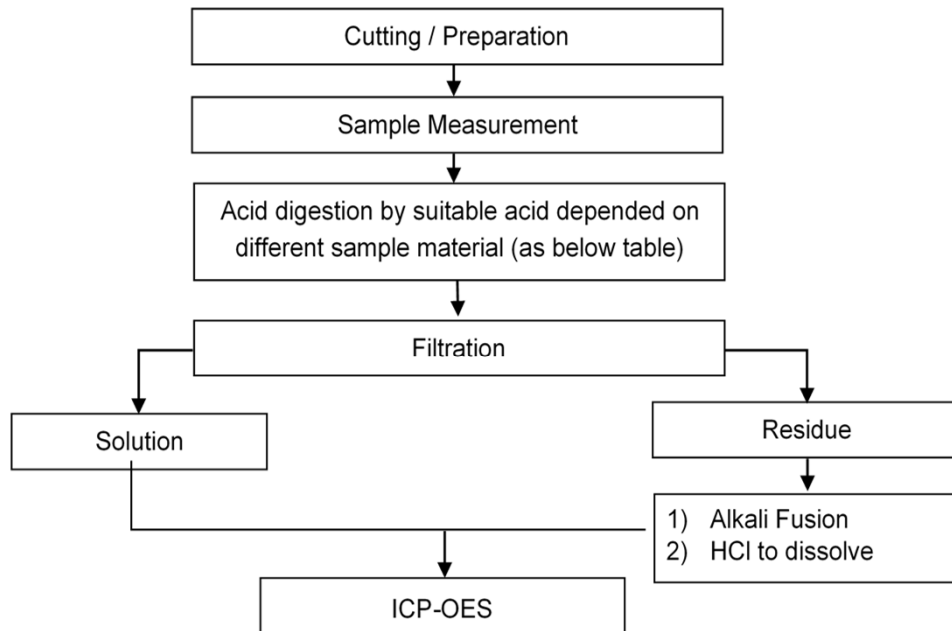
Analytical flow chart - Phthalate
