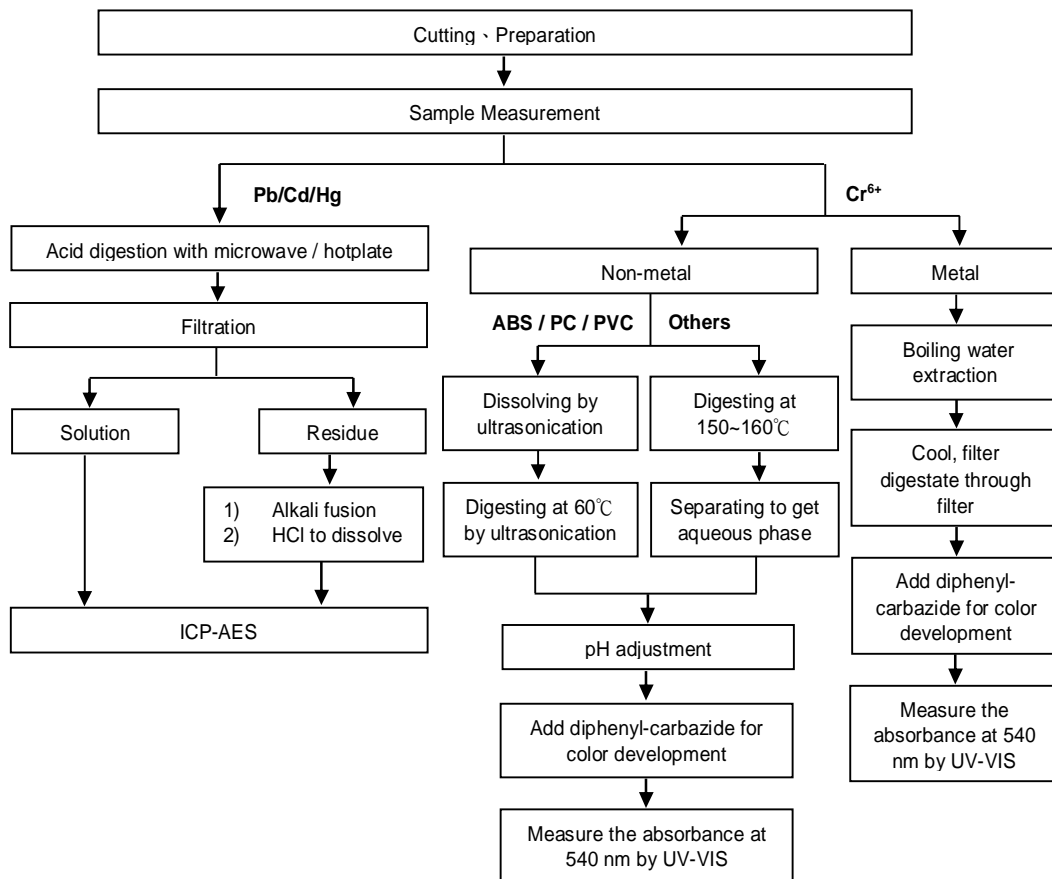

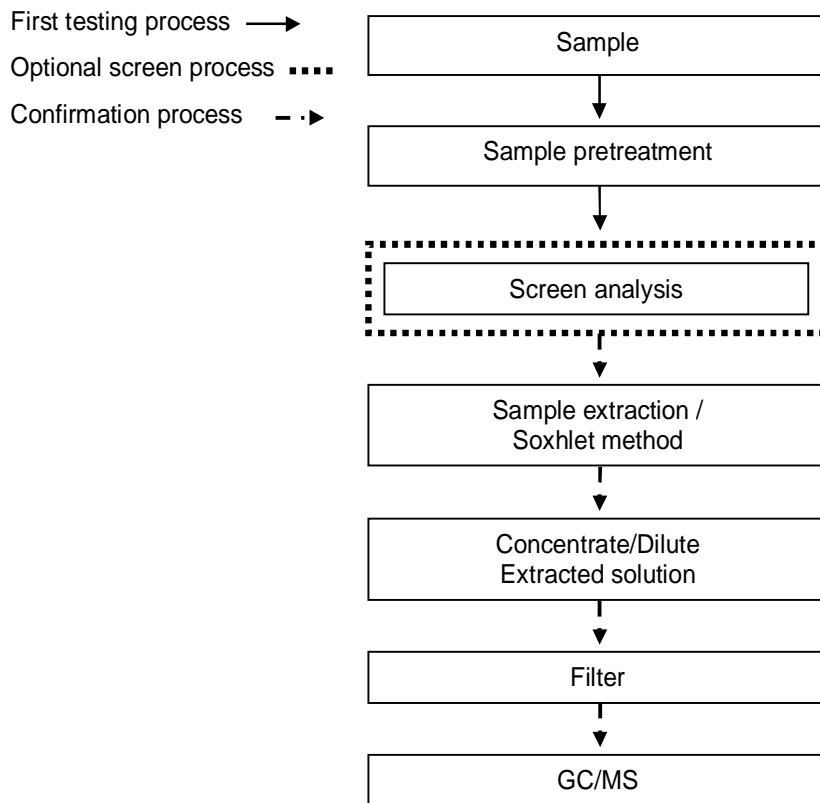

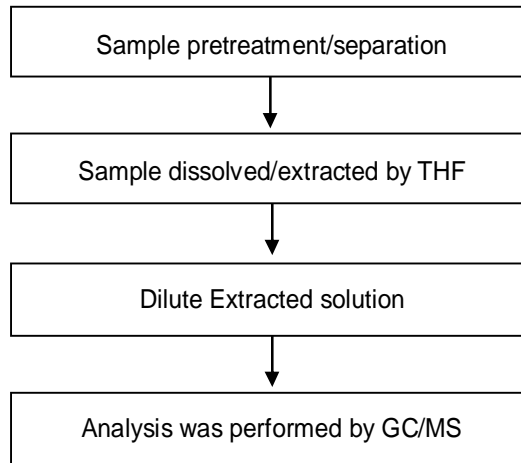

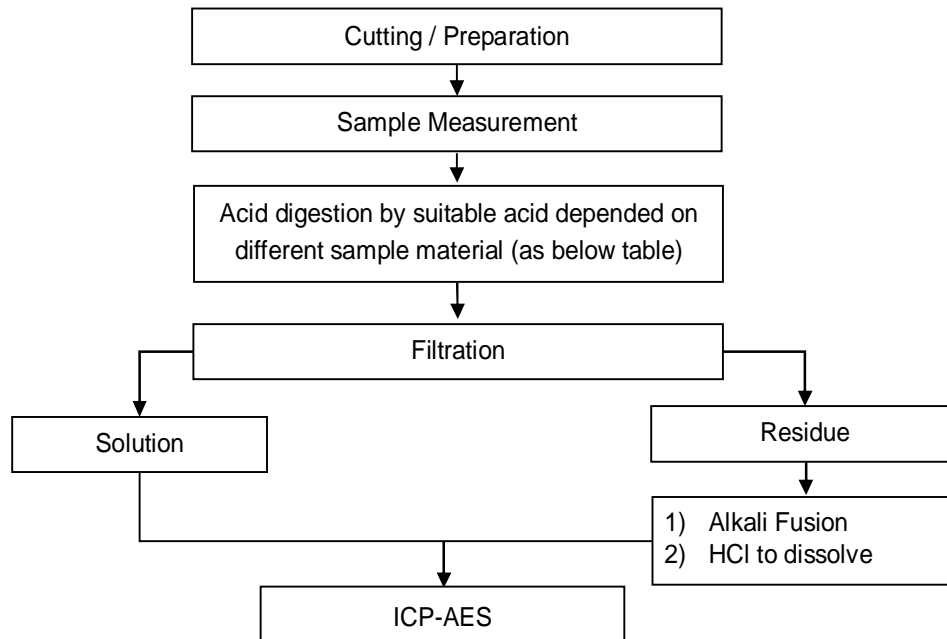

Flow Chart of digestion for the elements analysis performed by ICP-AES

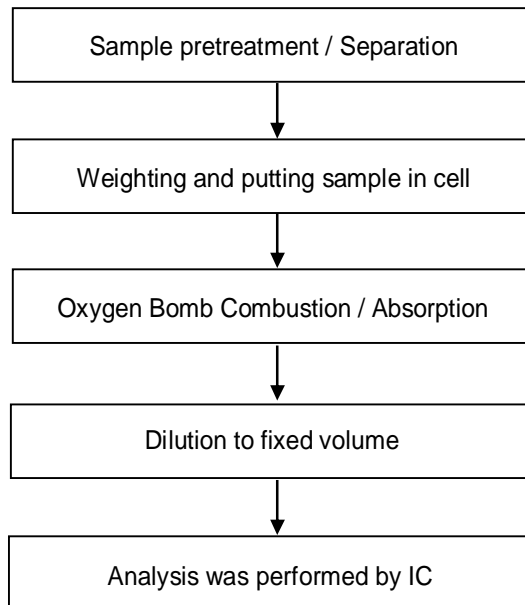
