


PRINTING PARAMETERS

RECOMMENDED REFLOW PROFILE

The recommended convection reflow profile for TSF-6592HF with Sn96.5Ag3.5, Sn99.3Cu0.7 or the various SnAgCu alloys is shown here. This profile is simply a guideline. As TSF-6592HF was engineered to be a versatile, robust interconnect material, other reflow profiles would be effective. Your optimal profile may be different from the one shown here based on your oven, component design, fixturing and mix of defects.
